# Community Spirit

The young people of Shepton Mallet continue to contribute to their community and complete another successful project.

After hearing about the "I am not lost" campaign which started in Canada four years ago, husband-and-wife duo Laney and Mark James from Paulton decided to kick off the trend in



the UK. In January they covered Bath City Centre with cosy items of clothing for the homeless. Young people of Shepton Mallet & East Mendip Project Team (YMCA MENDIP AND SOUTH SOMERSET) felt inspired by idea and wanted to follow it on in Shepton Mallet.

The project team met with the young people of Shepton Mallet who decided that this would be a great thing to do for their community. The young people and the project team started by asking for donations of scarves, hats, gloves and other warm items of clothing. Once these had been collected they put a tag on each item saying 'I am not lost. If you are cold, please take me to keep yourself warm'. The items were then distributed around Shepton Mallet by the project team and young people on Sunday 4th March, leaving them on benches, lampposts and in other public places. The young people felt that this would really benefit the people in need in the recent cold weather.

YMCA Mendip are very proud of the young people that took part, proving they do care about their community. YMCA Mendip would like to thank everyone that helped and donated their time and items.



# Plastics and Parishes

Parish councils concerned about plastics and interested to see how they can reflect their residents' views should contact Somerset Waste Partnership (SWP).

SWP has a major role in plastics through kerbside collections and recycling sites, collecting millions of plastic bottles and tens of thousands of Tetra Pak-style beverage cartons and single-use coffee cups; a total of almost 3,500 tonnes a year.

It has emphasised how no plastic sent by SWP to be recycled or landfilled today either ends up in China or in the oceans. All Somerset plastics – and 96% of all recycling – are reprocessed in the UK and Somerset landfills its rubbish near Castle Cary and Bridgwater.

SWP plans to divert far more plastics away from landfill and into recycling, including kerbside collections of Tetra Paks and plastic pots, tubs and trays, and to generate electricity from waste.

And it is:

- Trialling taking plastic pots, tubs and trays at five recycling sites for the month of March.
- Acting as Somerset hub for the national Refill project to encourage retailers to offer free water refills.
- Funding 90 school visits on waste issues by a Somerset eco-education charity.

# Home is Where the Heart Is

Homelessness Prevention Act 2017 comes into effect in April this year, and it changes the landscape for local authorities and people who are struggling with accommodation problems.

Authorities now have a duty to help everyone who is homeless – not just those who are assigned a high priority. So those who have had trouble paying their rent, or have somehow caused the loss of accommodation can now expect help.

They now have to help when homelessness is likely within 56 days. So if you have a notice from your landlord, they should be able to help you.

Prisons and hospitals now have a duty to notify the local authority when someone who may be homeless is released. This has been a part of the problem in the past.

The law still offers no help if the person concerned is not from the UK.

Citizens Advice Sedgemoor reported recently on a research project on Homelessness, and these provisions are very welcome. They address some of the main causes of sleeping rough.

Help that is offered under the new Act may be about preventing the person from being evicted, or advising them about finding accommodation.

In the end the simple fact is that there is not enough housing for local people, and many people are unable to afford what there is. Most benefits claimants need 1-bed property and demand is far greater than the property that is available. Housing Benefits have been frozen since 2012 but rents are rising. This is worsening in our area as workers building at Hinkley Point are arriving and they need accommodation.

Last year Citizens Advice Sedgemoor saw 150 people who reported that they were homeless – so this is a problem in Somerset and it has been growing in recent years. Many of these people feel hopeless and desperate.

Chief Executive Amy Jones says “We began with the greatest respect for those working in Sedgemoor... they are honourable people working as hard as they can... All the “players” mentioned... builders, landlords, agents and tenants play a vital part.”

## Raising awareness

The East Mendip Project Team (YMCA Mendip) have been working with young people in Frome for last six weeks at the local parks. Young people were concerned about the use of drugs in their community and wanted to make people aware of the dangers and risks involved in taking drugs. They also wanted to provide their community with helpful information on where to seek advice and help.

**WOMEN'S VOTE CENTENARY FUND SMALL GRANTS SCHEME** - Grants up to £2,000 for community organisations, schools, colleges, and universities in England for local activities that mark the centenary of women gaining the right to vote (application deadline 18<sup>th</sup> May 2018).

Applications for Round 2 of the Fund opened on **15 March 2018** and will close on **Friday 18 May**. **PLEASE NOTE:** activities for Round 2 must start by 31 August 2018. **Round 3** applications will be accepted from **Thursday 12 July 2018 to Friday 14 September 2018**. Guidance notes and an application form can be found on the [Government Equalities Office website](#). Groups must apply through the [application portal](#).

**JEAN SAINSBURY ANIMAL WELFARE TRUST** - Grants up to £35,000 to registered charities for projects or activities which benefit, protect and encourage a greater understanding of animals (next application deadline 01<sup>st</sup> May 2018).

The remaining application deadlines for 2018 are:

- Tuesday 1 May (for the Trust's summer meeting); and
- Saturday 1 September (for the Trust's winter meeting).

**WOMEN FIRST INNOVATION FUND** – Grants up to £10,000 for projects which enable women on low incomes to access new skills, training, confidence building and employment opportunities (application deadline 11<sup>th</sup> May 2018).

The deadline for applications is **5pm on Friday 11 May 2018**. Successful applicants will be announced in July 2018. **FUNDING FOR FIELD MONUMENTS** - Grants for landowners and tenants in England who wish to make improvements to monuments in their fields; including ruins, scattered remains, earthworks or standing structures (applications may be made at any time).

**POST OFFICE COMMUNITY BRANCH FUND** – Grants of £10,000 or more to support a wide range of branch improvements to help grow business and improve customer service (applications may be made at any time).

Interested parties are required to complete an [application form](#) including details of their investment idea and how much they'd like to apply for. If the application is successful, the funder will send confirmation of the investment within 28 days. Further information is available on the [Post Office Community Fund web page](#).

**ARTS COUNCIL NATIONAL LOTTERY PROJECT GRANTS** - Grants up to £100,000 for arts, museums and libraries projects in England that engage people with arts and culture (applications may be made at any time).

**THE NORMAN FAMILY TRUST** - Grants up to £10,000 for registered charities and other non-profit, voluntary organisations working in South West England, particularly in certain areas (applications may be made at any time).

An application form is available from the [Norman Family Charitable Trust website](#). The completed form should be submitted by post to the Trust. Applications for over £5,000 will be considered at quarterly meetings of trustees while grants of less than £5,000 are delegated to a sub-committee which meets every 6-8 weeks.

**THE GREGGS FOUNDATION LOCAL COMMUNITY PROJECTS FUND** - Grants up to £2,000 for local not-for-profit organisations to deliver projects or provide equipment to people in need at the heart of their local communities (application deadline 22 June 2018)

The second and final deadline for the Local Community Projects Fund this year is **midnight on Friday 22 June**. Successful applicants will be announced by Friday 17 August 2018.
