Somerset Waste Partnership (SWP) is urging Mendip parish councils to remind residents about how to sort out any issues with waste services, including the easy route for most of going online.

For many services, including arranging a garden waste collection, the starting point should be Mendip District Council's waste page: <http://www.mendip.gov.uk/waste>. And then, for anything relating to kerbside pick-ups, from reporting a missed collection to ordering replacement containers, contact Mendip's customer services team on 0300 303 8588 or use the form at <https://www.mendip.gov.uk/contactus>.

For questions about the Frome or Wells (Dulcote) recycling sites, Somerset Direct has the answers on somersetdirect@somerset.gov.uk or 0300 123 2224, or information can be found about what goes where, and when sites are open, here: <https://www.somersetwaste.gov.uk/recycling/centres/>.

SWP's own site at www.somersetwaste has a host of information, advice and support on reducing waste, reusing items, and what can – and cannot – be recycled at the kerbside and at recycling sites, as well as all specialist services, such as assisted collections for those unable to fill or move their bins and boxes.

THE JAMES TUDOR FOUNDATION - Grants up to £50,000 for UK registered charities working in the areas of palliative care, medical research, health education, the relief of sickness, and the prevention and relief of sickness overseas (applications may be made at any time).

THE DAN MASKELL TENNIS TRUST - Grants up to £1,500 to enable disabled people in the UK to play tennis through the purchase of wheelchairs, tennis equipment and funding for coaching (next application deadlines 1st July and 2nd October 2018).

Before applying to the Trust for grant support, applicants are advised to consult [The Tennis Foundation](#) and/or their local [County Tennis Association](#). Application forms are available to complete online on the [Dan Maskell Trust's website](#).

THE HILDEN CHARITABLE FUND – Grants up to £5,000 for UK groups working in the areas of homelessness, asylum seekers & refugees, community based initiatives for disadvantaged young people, penal affairs, and overseas development (applications may be made at any time).

An application form is available on the [Hilden Charitable Fund website](#) (you'll need to scroll down the page to the relevant link). but must then be printed out and sent as a hard copy by post to the Fund.

BIG LOTTERY FUND RELAUNCHES ITS REACHING COMMUNITIES PROGRAMME FOR ENGLAND – Revenue and capital grants over £10,000 for voluntary and community organisations to act on the issues that matter to people and communities (applications may be made at any time).

Potential applicants are advised to observe the following application process:

1. Check the [eligibility requirements](#) on the [Big Lottery Fund website](#);
2. Read the [guidance notes](#);
3. Contact the Big Lottery Fund, either by telephone or by email, to discuss the proposed idea.

THE PAUL BUSH FOUNDATION - Grants up to £10,000 for registered charities working in England to support the needs of adults and children with acquired physical disabilities as a result of an accident or birth injury (applications may be made at any time).

Applications may be submitted at any time and are considered twice a year in April and October. Guidelines and an application form are available on the [Trust's website](#). Applications should be submitted by post along with a copy of the latest annual report and audited accounts in hard format.

THE WHITLEY ANIMAL PROTECTION TRUST - Grants for registered charities carrying out animal welfare activities in the UK (applications may be made at any time).

The Trust does not maintain a website. Neither does it advertise an email address. Further information is, however, available on the [Charity Commission website](#).

NEIGHBOURHOOD PLANNING GRANT PROGRAMME EXTENDED UNTIL 2022 - Grants up to £15,000 plus technical support for town and parish councils



and neighbourhood forums in England to draw up a neighbourhood plan or neighbourhood development order (scheme to run until March 2022).

There is a two stage application process. Entry to the programme is through an [Expression of Interest form](#), which may be submitted at any time. For further information, guidance notes and to access the Expression of Interest form, visit the [Locality website](#).

THE WAKEHAM TRUST - Grants up to £2,500 for UK registered charities, community and voluntary groups to support small scale projects with a community emphasis that are finding it hard to obtain funding elsewhere (applications may be made at any time).

MUSIC IN THE COMMUNITY GRANTS - Grants up to £2,500 for UK based community groups to bring musical projects to their local communities (application deadline 1 July 2018).

There are three application deadlines each year. **The next deadline is Sunday 1 July** for projects to start from September the same year. The following deadline is Thursday 1 November for projects to commence in January 2019, The deadline after this is Friday 1 February for projects that should start from April 2019.
