Local Land Charges Fees

Calculation of Charges with effect from 1st April 2018.

Under Statutory Instrument 3248 9 (1) each local authority must publish a statement setting out how the charges are calculated. I have below shown the requirement of the Statutory Instrument and the method of calculation by Mendip District Council follows in bold:

a. the estimates the local authority has made under regulation 6(2) in respect of the unit charge for the following year.

The estimated total income for Mendip has been estimated at £220,000 and the following number of requests for the year is estimated at 4,500. The total cost of the service is estimated at £215,000 resulting in a small surplus of £5,000. Estimated cost recovery is 1.024%, thereby leaving a small margin of error for the new costs calculation. As it would be unlawful to budget for a profit, it should be stated here that any over (or under) recovery would be reflected in future fees iterations to ensure full cost recovery for the Council aligned with best value for the customer.

b. the basis for those elements.

The cost of the service is based on anticipated costs for 2017/18 as revised in the budget round for 2018/19. We have assessed that this is the most accurate data to project costs for 2018/19. The number of requests has been based on requests made during 2017/18.

c. The amount of the unit charge it proposes for the following financial year.
